UCC EFILE PUBLIC API

The Georgia Superior Court Clerks' Cooperative Authority offers a public Simple Object Access Protocol (SOAP) API that allows the submission, payment, and processing of UCC Filings. Filers may use this system in order to submit and pay for UCCs that are then processed by county users, either to accept or reject the filing on their end.

To make use of this document, first read the GSCCCA UCC eFiling Filer Implementation Guide found on https://efile.gsccca.org/Implementers.aspx.

The UCC GSCCCA File XML Guide details the modified IACA File XML schema that is used to submit new UCCs as well as transfer details on recording and acknowledgement information.

ASSUMPTIONS

This is a technical document intended for developers and service providers who wish to utilize the UCC eFile API programmatically. Anyone reading this document should be well versed in XML and XSDs, as well as have knowledge on how to connect to a SOAP web service to make calls and process responses. Expectations are that readers will be familiar with the basics of the IACA File XML and IACA Status and Receipt XML formats. Lastly, familiarity with UCCs and Georgia's laws will be beneficial.

XML SCHEMA

The XSD file defining the IACA File XML schema can be downloaded on the Implementer's page linked above under the UCC eFiling Related Files heading.

GSCCCA UCC EFILE API


This schema is used in the public eFile API for the purposes of submission of new filings and the retrieval of modifications based on county processing (acceptance or rejection). Once submitted, the only time the filing will be modified is by the county for processing purposes or through resubmittal of a rejected filing.

SCHEMA DEFINITIONS

This XML schema is based on the IACA Receipt and Status XML schema with a few modifications. Use these definitions along with the downloadable XSD to ensure compatibility in your system.

In the element and attribute lists, description will give any basic details of utilization, attribute value will detail any formatting requirements, and length will specify maximum possible size.

DOCUMENT



The Document element is the root element of the GSCCCA File XML. It contains the XMLVersion, Header, and Record elements. The FileSignature element is ignored the GSCCCA.


The Only one UCC, and thus Record element, can be included in a single submission. If more than one Record element is included, an error will be returned by the eFile system.


HEADER


TEST


FILER



Filer information is included here. When the filing originates on the eFile website, and not through the UCC eFile API, then this information will be pulled from the forms filled out by the filer when creating or editing their account information.

NAMES



The names field contains more details on the filer. Several elements are not currently used by the GSCCCA and will be ignored by the system.

Tax IDs must not be included in the submission. If included, the eFile system will return an error.


If the filer is an organization, then OrganizationName must be included, otherwise IndividualName must be included. There is never a time when both of these elements can be included at the same time.

RECORD

The record element contains all relevant filing information about the UCC.

See Appendix A for information on the allowed values for TransType, AmendmentType, and AmendmentAction. See Appendix B for information on how the GSCCCA interprets and will submit UCCs based on how these values are set at the time of submission.

SubmitterRef is a required field, and it must be a unique value. It will be used to ensure that a filer does not accidently submit the same UCC multiple times as a protective measure to prevent the accidental filing of documents.


DocumentReceiptID is assigned the value of the Filing ID, which can be found on the eFile website dashboard as the identifier of all UCCs filed. This value will be necessary to perform future actions and will be returned the filer upon initial submission.

FileInRealEstate is not allowed by the GSCCCA. If a filer wishes to file a real estate document, then the real estate eFile API must be used.

Collateral can be used to attach collateral documents to the UCC that will be recorded as part of the filing. These must be base64 string encoded. For more information on attachments and data requirements see Appendix C.


Acknowledgement is for use only by the county of recording. When accepted or rejected, values here will be populated.


ACKNOWLEDGEMENT

The Acknowledgement section is for use by the recording county only.

This section contains recording information, such as file number, book, page, date, and fees. It also will contain rejection information in cases where the UCC is rejected, using the Errors section.

The FileStatus uses various GSCCCA status values necessary to convey the Georgia designated workflow. These are defined in Appendix A.

The format for filing numbers in Georgia are CCC-YYYY-##### where CCC is the numerical county designation, YYYY is the year of recording, and ###### forms a unique series.

In order to help facilitate quick and accurate processing by the county, please ensure that these values as assigned match as expected the filed PDF UCC filing attached to the submission itself.

APPENDIX C - VALIDATION, PARSING, AND DATA REQUIREMENTS

Upon submission of a UCC, the eFile system will validate your XML against this schema and parse relevant values.

OFFICIAL UCC FORM

The XML data does not currently define the official UCC document, as the GSCCCA eFile system utilizes a Level-2 transfer system. This means that the filled out PDF form that is sent alongside the GSCCCA File XML is the official UCC document while the XML is used by the system to parse data and make determinations about the submission such as the UCC type.

ELEMENT AND ATTRIBUTE REQUIREMENTS

Several elements in the XML schema are not directly defined in this document. Either they are listed as "Ignored by GSCCCA," "Must be <value>," or they explicitly will give an error in certain cases or if included.

IGNORED BY GSCCCA

Elements and Attributes that are designated as ignored by the GSCCCA are included in this XML schema for potential forward compatibility. At the moment, validation checks to ensure that the submitted XML conforms to the XSD, but no checks is made that the data is usable.

MUST BE...

Some element or attributes have required values. The system will ensure that these elements or attributes conform to the system's expectations and will create an error response in cases where incorrect values are included. In the future, the expected values for these may change, so the XSD still allows them to validate against and errors will be thrown by the system during parsing.

CALLBACKS

The GSCCCA offers the use of callbacks – that is calling a SOAP web method set up by a filer upon change in status of a filing that user submitted. If a ReturnURL is given in the XML, then the system will attempt to perform a callback when the UCC is accepted or rejected. MAXIMUM PAYLOAD

Total maximum submission size is calculated including all submitted data, with XML size in bytes and UCC PDF size added together. With the XML data, the main contributor to document size when size is consequential will be the collateral attachment which is a base64 encoded string representing a PDF document. In cases where you include this attachment in the XML, ensure that its size summed with the submitted PDF do not exceed the maximum allowed size set by the Submit() web method in the UCCService.asmx service.

The current maximum payload is 10 Megabytes.
